



TOWN OF MUKWONAGO
PARK SHELTER PRIVATE USE AGREEMENT

In consideration of being conditionally allowed to use a park shelter in a Town of Mukwonago Park, the undersigned Person Responsible, individually, and also the below-named Organization (if any) (Person Responsible and Organization, if any, referred to hereinafter, collectively, as "User") hereby agree as follows:

- 1. The User accepts and shall fully comply with the Town of Mukwonago Park Rules Ordinance (Ordinance No. 2002-19), which is attached hereto as Exhibit A, and incorporated herein by reference.
2. The Person Responsible hereby states that he/she is a Town of Mukwonago ("Town") resident or Village of Mukwonago ("Village") resident, and hereby agrees to be present at all times throughout the private use of the Town park shelter.
3. The User shall pay in advance, with this application, a \$25 plus tax amount owed for rental equals \$26.28) fee for a "Town" resident or \$50 plus tax (amount owed for rental equals \$52.55) fee for a "Village" resident for each day of use or portion thereof and a \$50 security deposit. If the fee and security deposit are paid by check, they must be paid by separate checks.
4. Security deposit will be returned to the Person Responsible if the Park Shelter is restored to a condition as it was prior to use by the Person Responsible. In the event any damage has been done or the Park Shelter has not been properly cleaned, the TOWN reserves the right to forfeit the security deposit to cover repairs and/or cleaning. In the event damages are done to the TOWN property exceeding the amount of the security deposit, the TOWN reserves the right to charge the Person Responsible for the additional expenses. The security deposit is not to be considered liquidated damages.
5. The Person Responsible shall be directly responsible for any damage done during the use period. If an Organization is named below, the Person Responsible and the Organization shall be jointly and severally responsible.
6. The User hereby agrees to indemnify, defend and save harmless the Town, its agents, servants, employees, assigns and independent contractors of and from any costs, fees (including Attorney fees of an Attorney of TOWN'S choosing) and all liability arising in any manner whatsoever with regard to personal injury or property damage that may arise during the User's preparation, use, or subsequent cleaning or repair of the Town park shelter and related activities.

THE ACCEPTANCE OF THIS FORM CONSTITUTES AN ACKNOWLEDGMENT AND ACCEPTANCE OF THE CONDITIONS AND REGULATIONS HEREIN NOTED. AT THE DISCRETION OF THE TOWN OF MUKWONAGO RECREATION DIRECTOR, RENTAL, IN SOME CASES OF TOWN PARK SHELTER MAY REQUIRE APPROVAL BY THE TOWN BOARD.
